Given the increasingly complex health histories of those who seek dental hygiene care across their life span, the growing evidence connecting oral health and systemic health, and the public's increasing need as well as demand for the prevention of oral disease and promotion of health, it is essential that dental hygiene students further their knowledge of case-based science as it applies to oral health care. Permitting community colleges to confer a Bachelor of Science degree in Dental Hygiene, Applied Science will better prepare students for patient care in California as well as provide them with the necessary foundation to enter a variety of employment settings that require the baccalaureate educated graduate.

Dental hygiene baccalaureate degree programs in California are currently offered at private colleges and universities, yet all dental hygiene programs in California must meet the same national accreditation standards, regardless of whether the specific institution confers a certificate, an associate degree or a baccalaureate degree upon graduation. pass the same National Dental Hygiene Board examination and the same clinical licensing board exams as students from baccalaureate degree programs.

In terms of workforce and future job opportunities, the dental hygienist has multiple opportunities and may work in the fields of research, education, the corporate oral health industry, public health, administration, as well as in clinical practice. These positions, including the advanced clinical practice of California's RDH in Alternative Practice, most often requires a minimum of a baccalaureate degree or its equivalent. California's public educational institutions have a responsibility to prepare their dental hygiene graduates for all areas of gainful employment.

With the evolving models of healthcare occurring across the nation, dental hygienists in California are positioned to assume even greater roles and responsibilities in the delivery of cost-effective, preventive oral health care and to increase access to care. The California Dental Association, in their recent Access to Care Report, reported that 30% of Californians are not being served or are underserved by our current dental workforce. Given the increasingly complex and varying needs of the public, baccalaureate degree dental hygiene programs in California public education institutions are vitally important to the future of oral health.

Santa Rosa Junior College Dental Hygiene program enthusiastically supports the Foothill College Dental Hygiene program in the development of a bachelor's degree in dental hygiene under the Senate Bill 850 pilot program allowing community colleges to offer four-year degrees. Offering bachelor degree coursework at the community college would complement existing dental hygiene programs and courses by providing education content that is necessary for many dental hygiene roles that are not generally included in Associate degree curriculum. Of primary importance is the inclusion of community and public health education. An important consideration when discussing the future of dental hygiene education is the trend towards evolving dental roles, particularly in education, care coordination and community health.

Health care is a rapidly growing industry that needs skilled people. According to a recent Forbes Magazine article, over a quarter of the jobs on the top-20 list are health-related, including dental hygienists (No. 15). In these jobs, employees must work in teams and will succeed if they are service oriented, empathetic and perceptive. The Health Care Reform Act is expected to bring additional changes to the profession as we see an increased demand for mid-level healthcare professionals. Healthcare Practitioners are among the 50 fastest-growing occupations; these occupations are expected to grow at a rate of 25.4% as compared to 16.3% projected for all occupations in the state. Labor Market projections: Health care is the ultimate "population serving" industry with trained professionals expected to achieve the goals of health care reform and meet the diverse state population. 

For competitive applicants to be considered for acceptance into this curriculum intense program, they have to first excel in two years of pre-requisite courses. Many of these courses included upper level science courses, such as, microbiology, biochemistry, anatomy and physiology. The Foothill College Dental Hygiene Program curriculum is set with the highest standards throughout. The students have an elevated grading scale where 93% earns an A. Some of the courses taken are Oral Pathology, Oral Biology, Radiography, Anesthesiology, Periodontics, Oral Anatomy, Public Health, many clinical hours, community service hours and professional hours. The students complete 128.5 units towards the Dental Hygiene major not including the pre-requisite work. This program was started in 1964 and since then, has had 100% of the students passing the Dental Hygiene National Board Examination each year consecutively. Students given the chance to earn a Bachelor's degree from completing this program will be well prepared to become great advocates for Oral Health and will enhance the public's perception of this important healthcare field.

Foothill College Dental Hygiene students are educated, committed and have proven their competence in the field. These skills reflect those obtained with a Bachelor's degree, rather than an Associate's degree. Therefore, we urge you to support State Bill 850, the pilot Baccalaureate degree program at the Foothill Community College Dental Hygiene Program.

Dear Chancellor Harris:

We are writing to express our strong support for the selection of Foothill College Dental Hygiene Program as one of the pilot programs to implement SB 850, which would allow for applied baccalaureate degrees in areas of high workforce demand at the community college level in California.

The Foothill College Dental Hygiene Program is one of the premier basic preparation dental hygiene programs in the state with a long and distinguished history of providing outstanding dental hygiene education and care. There is a great need for having community colleges confer a Bachelor of Science degree in Dental Hygiene, Applied Science given the increasingly complex health histories of recipients of dental hygiene care across the life span, the connection between oral health on general health, and the increasing need and demand for the prevention of oral disease and the promotion of health by the public. As current students of Foothill College Dental Hygiene Program, we cannot think of a better environment to pilot test an applied baccalaureate degree in dental hygiene than within the Dental Hygiene Department at Foothill College.

Please consider in your deliberations that the only dental hygiene baccalaureate degree programs available in California are at private colleges and universities. We will graduate with over 150 quarter units to receive the Associate of Science degree. We will also take the same National Dental Hygiene Board examination and the same clinical licensing board exams as students from baccalaureate degree programs. In terms of workforce and future job opportunities, the dental hygienist may work in the fields of research, education, the corporate oral health industry, public health, administration, as well as in clinical practice. Most of these positions outside of clinical dental hygiene would require a minimum of a baccalaureate degree for entry to the field. It is vitally important that there is baccalaureate degree dental hygiene in California public education institutions, such as Foothill College. With the evolving models of healthcare, mid-level healthcare providers and the evidence of oral and systemic health relationships, the dental hygienist will be an important player in these new, emerging models. There is a need for such a program given the increasingly complex and varying needs of the public in the private and public practice of dental hygiene.

As current students of the Dental Hygiene program at Foothill College, we are confident that this college is well placed to develop a baccalaureate degree program. The program is well respected throughout California. Therefore, Foothill College Dental Hygiene program is an excellent choice to develop a bachelor's degree program in a community college setting.
